### ELC Consumer Statement for New SR Families

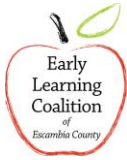
Dear Parent,

The funding you receive to help pay for your child care are Child Care Development Funds (CCDF). CCDF is federal funding designed to provide equal access to a range of high-quality child care for eligible children. CCDF funds provide opportunities for School Readiness providers to receive training and technical assistance to enhance the quality of their child care programs and the early childhood workforce. These funds are also used to help connect parents with consumer education and provide access to a full range of child care choices. The Early Learning Coalition of Escambia County contracts with child care providers to provide school readiness services. These providers must meet or exceed state and local requirements for health and safety. We recommend you review the [inspection information](#) for the provider you have selected to care for your child. The inspection reports will provide information on the following:

- The date of the provider's last health and safety inspection,
- Past three years of inspection reports, with a history of any health and/or safety violations,
- Provider's Gold Seal status.
