III. Consent Agenda

a. Financial Report

Through October the Coalition has spent \$5.1 million of the \$17.3 million of the SR grant which is 29.6%. Admin was 2.4%, Non-Direct Total 17.5% and Quality 9.0%. VPK Admin is under 4% at 3.6% as predicted now that the Coalition has started paying for VPK services for the year.

b. Enrollment/Wait List Status Report

There are 2,520 children enrolled in the School Readiness Program. There are 674 children on the Wait List. The last pull from the Wait List was on November 14, 2023. There are 1,681 children enrolled in VPK.

c. Contracting and Fraud Summary Report

There are 81 SR providers and 73 VPK providers. There are seven pending fraud cases.

a. ARPA Discretionary Grant Funding

The Coalition has begun spending the ARPA Discretionary and ARPA Early Learning Discretionary grants. Over \$2 million has been spent in November alone. The Coalition is using sole source and RFP processes that are charting new ground in procurement. The first sole source application was approved by the DEL. This was for the purchase of Teachings Strategies curriculum materials totaling \$350,000.

b. RFP for Accounting Program

Two packages have been submitted from the RFP for the accounting program. These packages will be opened tomorrow for review. It was discussed to have a couple of the Executive Committee members to sit in on the review process. The chosen accounting program will be presented at the December 2023 Board meeting for approval.

c. <u>Joyce Griffin Center</u>

The Coalition has raised \$331.00 through donations for the plaque to dedicate the Training Room. Total Costs are estimated to be \$500. Once sufficient funds are raised, the plaque will be purchased, and a date and time will be set for the dedication ceremony.
